- ◆ To gives Legal support for property and family proble

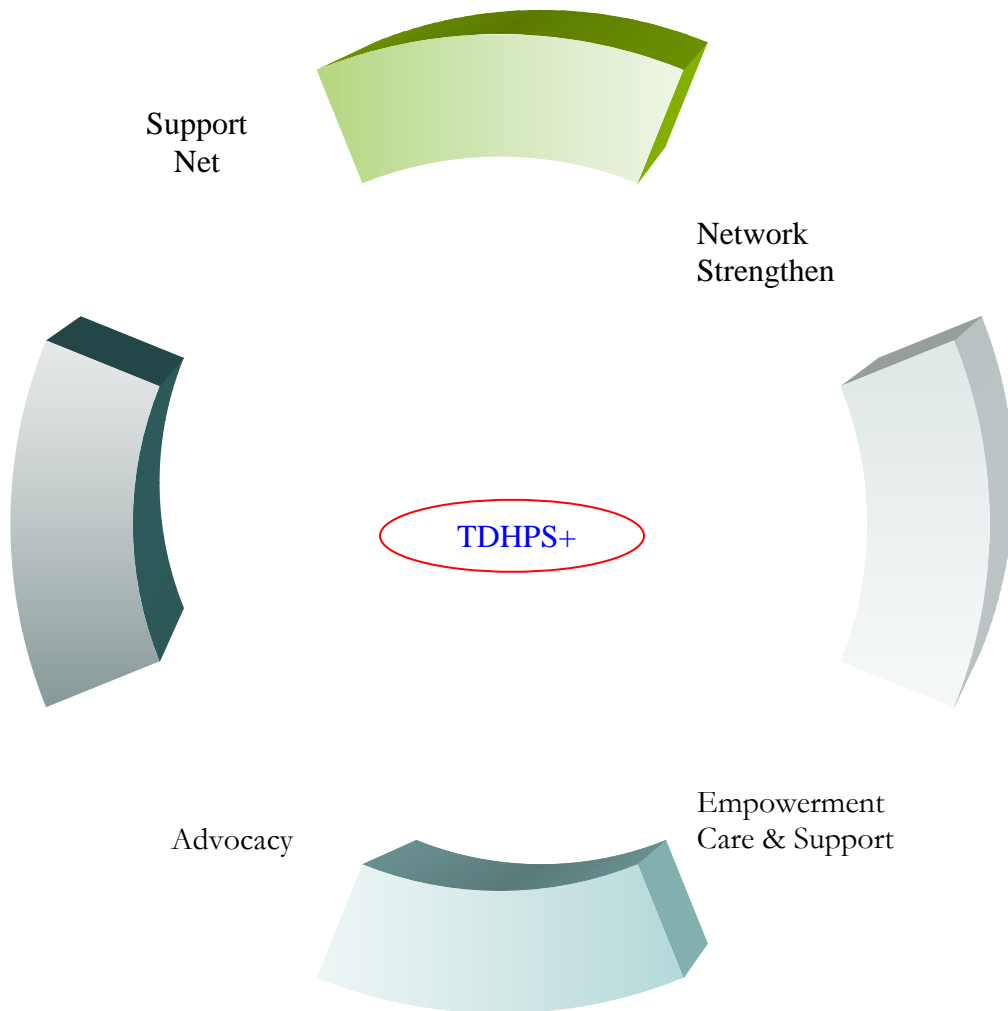
